### ANNUAL MEETING HIGHLIGHTS FEBRUARY 17, 2009

The CFLA Credit Union Annual Meeting for the year 2008 was held on February 17, 2009, at Palaza Bernardo. A total of 73 members attended. Vice-President Gussie Hahn opened the meeting. The minutes from last year's annual meeting were reviewed and approved by the members.

President Adrian Worries recognized Board members and Supervisory Committee members, and Kathy Acosta as Credit Union Manager.
